PrimeXBT Terms and Conditions - Invite & Earn Program

Introduction

1.1. PrimeXBT (PTY) LTD is an authorised financial services provider in South Africa with license number 45697, with registration no. 2013 / 099697 / 07 and having its registered address at 180 Lancaster Road, Gordons Bay, Gordons Bay, Western Cape, 7140 (hereinafter referred to as the **“Company”**, **“PrimeXBT,”** **“we,”** **“us,”** **“our,”** as appropriate). PrimeXBT (PTY) LTD acts as an intermediary between the investor and the market maker which is the counterparty to the products purchased through PrimeXBT.

1.2. The Company is not the market maker or product issuer and acts solely as an intermediary in terms of the FAIS Act between the Client and the liquidity provider, rendering only an intermediary service (i.e., no market making is conducted by the Company) in relation to the products offered. Therefore, the Company does not act as the principal or the counterparty in any of its transactions.

1.3. The following Invite & Earn Program Terms and Conditions (hereinafter the **“Invite & Earn Terms”**) apply to all clients (hereinafter referred to as the **“Client(s),”** **“you,”** **“your”**, as appropriate) of the Company.

1.4. PrimeXBT provides its Clients with the opportunity to earn referral rewards through the Invite & Earn Program. Under this program, eligible Clients may receive rewards based on the trading activity of their direct referrals, as described in Clause 3 below.

1.5. The Client’s participation in the Invite & Earn Program shall constitute his/her full and unequivocal acceptance of these Invite & Earn Terms, the PrimeXBT Terms and Conditions, referred to as the **“Agreement”**, that govern the relationship between the Company and all of its Clients, and all relevant Policies, collectively referred to herein as the **“Terms”**, the latest versions of which are available at all times on the PrimeXBT Website, as may be amended from time to time.

1.6. The Invite & Earn Terms serve as a supplement to the Company’s Agreement. Any and all terms and conditions included herein are effective and are to be read in conjunction with the Company’s Agreement and any other policies available on the Company’s Website. Any and all terms and conditions governing, inter alia, the offer, execution, conditions, prohibitions, termination, warranties, rights and restrictions for any products and services included in the Agreement shall apply without limitation to the Invite & Earn Terms. In the event of any discrepancy between the Invite & Earn Terms and the Agreement, the terms of the Agreement shall prevail.

1.7. The Invite & Earn Program and all PrimeXBT products and services are not available to any person who resides in a restricted jurisdiction or to a US Reportable Person, as defined in the Company’s Agreement. Please visit the Restricted Jurisdictions section on our website for more information.

1.8. The Client acknowledges and agrees that the availability of certain products, platforms, bonuses, competitions, contests, promotions, campaigns and services may be restricted or unavailable in certain jurisdictions, at the Company's sole discretion.

2. Eligibility

2.1. To be eligible to participate in the Invite & Earn Program, you must:

- i. be an existing and approved PrimeXBT Client in accordance with the Company's Agreement, available on the Company's official website;
- ii. be a natural person with full legal capacity and over eighteen (18) years of age; and
- iii. have access to the unique referral link, hereinafter the "Referral Link", available on the PrimeXBT platform here <https://primexbt.com/my/referral>, hereinafter the "Platform".

2.2. Where the above conditions are satisfied, the Client is eligible to participate in the Invite & Earn Program and invite other eligible persons to the Company's Platform, hereinafter the "Referrer".

2.3. The Company reserves the right, at its sole discretion, to determine a Client's eligibility to participate in the Invite & Earn Program and to restrict, suspend or terminate participation at any time.

3. Reward Conditions

3.1. Under the Invite & Earn Program, the Referrer may earn a reward equal to twenty percent (20%) of the applicable trading fees, spreads and/or commissions generated by the Referrer's direct referrals only.

3.2. For Contracts for Difference, hereinafter "CFDs", the Referrer's reward shall be calculated on the basis of twenty percent (20%) of the spread generated by the direct referral's eligible trading activity.

3.3. For Crypto Futures, the Referrer's reward shall be calculated on the basis of twenty percent (20%) of the commission generated by the direct referral's eligible trading activity.

3.4. Referral rewards are currently paid in USD and/or USDT, depending on the relevant region, product, platform or operational setup applicable at the time. The Company reserves the right, at its sole discretion, to change the payout currency, payment method, wallet type or any related operational mechanics at any time without prior notification.

3.5. The available balance for withdrawal is updated every twenty-four (24) hours. Accordingly, any

eligible referral reward generated by the trading activity of direct referrals will generally appear in the Referrer's account after approximately twenty-four (24) hours. The Company reserves the right, at its sole discretion, to amend the above timeframe at any time and without prior notice.

4. Invite and Earn Program Details

- 4.1.** Clients must refer new users to PrimeXBT using the unique referral link provided on the platform.
- 4.2.** Please note that eligibility for the opportunity to receive a gift of up to \$100 may apply only where the referral link used for registration was generated by clicking the "Send a Free Gift" button on the Referral Program page, and is subject to any applicable conditions, eligibility criteria and availability.
- 4.3.** Any eligible referral reward earned by the Referrer may be credited to the Referrer's wallet as withdrawable funds and may also be used for trading purposes, subject to these Invite & Earn Terms and any applicable operational rules or procedures.
- 4.4.** Self-referrals, or any arrangement intended to circumvent the purpose of the Invite & Earn Program are strictly prohibited.
- 4.5.** This Invite and Earn Program is ongoing, and PrimeXBT reserves the right to amend, suspend or terminate the program at its sole discretion.

5. Legal Information

- 5.1.** The Clients hereby acknowledge and agree that PrimeXBT shall not be liable for any claims, costs, expenses, losses, damages, tax liability, or any other harm suffered by any Client, or person as a result of engaging with the Invite and Earn Program. This might include, inter alia, any trading losses or loss of profit incurred during participation in the Invite and Earn Program, usage of Reward credit, or any error, technical malfunction, or breakdown in the PrimeXBT Website, Trading Platform, or any related computer system, mobile application, downloadable software, or equipment, including that of the Client.
- 5.2.** Any fraudulent activities or abuse of the Invite and Earn Program will lead to disqualification and potential account suspension.
- 5.3.** If PrimeXBT identifies that an individual is not eligible to participate in the Invite and Earn Program and receive Rewards, PrimeXBT may then at its discretion invalidate any granted Referral Links or reverse and withdraw any Rewards credited. No individual shall be entitled to any payment or compensation from PrimeXBT should any Reward or corresponding profit be forfeited, canceled or reclaimed.
- 5.4.** The decision of PrimeXBT on all matters relating to the Invite and Earn Program and Rewards shall be final and binding on all participants. PrimeXBT reserves the absolute right to cancel, amend, revoke, or withdraw the Invite and Earn Program and/or withdraw, amend, cancel, revoke any

credited Reward(s) and/or profits accumulated from such Reward(s) to any Referrer at any time and without the obligation to provide any reasons or explanations.

5.5. PrimeXBT reserves the right, at its sole discretion, to remove any individual, Referee, or Referrer from the Invite and Earn Program. In addition, the Company reserves the right at its absolute discretion not to pay, cancel or withhold any Reward.

5.6. PrimeXBT reserves the absolute right upon its discretion to deny participation in the Invite and Earn Program or terminate a Client's participation in the Invite and Earn Program.

5.7. By participating in the Invite and Earn Program and submitting their details and information, Clients hereby grant PrimeXBT explicit consent to use, store and share such information for marketing and promotional purposes of PrimeXBT, its affiliates, partners, and/or sponsors. This may include, but is not limited to, the dissemination of marketing materials, promotional offers, and other communications related to PrimeXBT's services and products. 5.8. Any dispute not covered by the relevant Invite and Earn Program Terms will be resolved by PrimeXBT in a manner it deems to be the fairest to all concerned, and that decision shall be final and binding on all parties.

5.9. If any term of the Invite and Earn Program Terms is found to be illegal, invalid, or unenforceable under any applicable law, such term shall be severable from the remaining terms, and the remainder of the Invite and Earn Program Terms shall remain valid and binding as if the severed term had never been included.

5.10. If these Invite and Earn Program Terms are translated into a language other than English, then the English version of the Invite and Earn Program Terms shall prevail wherever any inconsistency arises.
